AN EXECUTIVE ORDER EXTENDING THE ALERT LEVEL 1 STATUS IN SAGAY CITY, VICTORIAS CITY, LA CARLOTA CITY, CADIZ CITY, TALISAY CITY, THE MUNICIPALITIES OF ILOG, ENRIQUE B. MAGALONA, PULUPANDAN, SAN ENRIQUE, CANDONI, PONTEVEDRA, VALLADOLID, AND THE ALERT LEVEL 2 STATUS FOR THE REST OF THE PROVINCE OF NEGROS OCCIDENTAL UNTIL AUGUST 15, 2022

WHEREAS, on September 10, 2021, President Rodrigo Roa Duterte issued Proclamation No. 1218, series of 2021 further extending the State of Calamity throughout the Philippines due to Coronavirus Disease 2019 (COVID-19) until September 12, 2022;

WHEREAS, under Proclamation No. 1218, series of 2021, Local Government Units are enjoined to render full assistance and cooperation and mobilize necessary resources to undertake critical, urgent, appropriate response and measures in a timely manner to curtail and eliminate the threat of COVID-19;

WHEREAS, Section 16 of Republic Act No. 7160 also known as the Local Government Code provides that within their respective territorial jurisdictions, local government units shall ensure and promote health and safety, and preserve the comfort and convenience of their inhabitants;

WHEREAS, on October 28, 2021, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) approved the recommendation to further expand the implementation of the Alert Levels System to Region VI wherein the Province of Negros Occidental was placed under Alert Level 2 until November 14, 2021;

WHEREAS, on October 29, 2021, the Province of Negros Occidental was placed under Alert Level 2 under the provisions of Executive Order No. 21-48, entitled: "An Executive Order Adopting the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) Alert Levels System for COVID-19 and Placing the Entire Province of Negros Occidental Under Alert Level 2 from November 1, 2021 to November 14, 2021", and further extended under the provisions of Executive Order 21-51 Series of 2021 entitled: "An Executive Order Extending the Alert Level 2 Status of the Province of Negros Occidental until November 30, 2021", and further extended under the provisions of Executive Order 21-55 Series of 2021 entitled: "An Executive Order Extending the Alert Level 2 Status of the Province of Negros Occidental until December 15, 2021"; and further extended under the provisions of Executive Order 21-58 Series of 2021 entitled: "An Executive Order Extending the Alert Level 2 Status of the Province of Negros Occidental until December 31, 2021"; and further extended under the provisions of Executive Order 21-61 Series of 2021 entitled: "An Executive Order Extending the Alert Level 2 Status of the Province of Negros Occidental until January 15, 2022"

WHEREAS, on January 14, 2022, President Rodrigo Roa Duterte approved IATF-EID Resolution No. 157-A, Series of 2022 wherein the Province of Negros Occidental was classified under Alert Level 3 from January 16, 2022 to January 31, 2022, and further extended under the provisions of Executive Order 22-03 Series of 2022 entitled: "An Executive Order Extending the Alert Level 3 Status of the Province of Negros Occidental until February 15, 2022"

WHEREAS, on February 14, 2022, President Rodrigo Roa Duterte approved IATF-EID Resolution No. 161-A, Series of 2022 wherein the Province of Negros Occidental was classified under Alert Level 2 from February 16, 2022 to February 28, 2022; thus, the entire Province of Negros Occidental was placed under Alert Level 2 under the provisions of Executive Order No. 22-04, entitled: "An Executive Order Placing The Entire Province Of Negros Occidental Under Alert Level 2 From February 16, 2022 Until February 28, 2022"; and further extended under the provisions of Executive Order No. 22-08, entitled: "An Executive Order Extending the Alert Level 2 Status of the Province Of Negros Occidental Until March 15, 2022"; and further extended under the provisions of Executive Order No. 22-11, entitled: "An Executive Order Extending the Alert Level 2 Status of the Province Of Negros Occidental Until March 31, 2022"; and further extended under the provisions of Executive Order No. 22-13, entitled: "An Executive Order Extending the Alert Level 2 Status of the Province Of Negros Occidental Until April 15, 2022"; and further extended under the provisions of Executive Order No. 22-17, entitled: "An Executive Order Placing Sagay City, Victorias City, La Carlota City, The Municipalities Of Enrique B. Magalona, Pulupandan, and San Enrique Under Alert Level 1 Status and Extending the Alert Level 2 Status of the Province Of Negros Occidental Until April 30, 2022"; and further extended under the provisions of Executive Order No. 22-18, entitled: "An Executive Order Placing Sagay City, Victorias City, La Carlota City, The Municipalities Of Enrique B. Magalona, Pulupandan, San Enrique, and Candoni Under Alert Level 1 Status and Extending the Alert Level 2 Status of the Province Of Negros Occidental Until May 15, 2022"; and further extended under the provisions of Executive Order No. 22-19, entitled: "An Executive Order Extending the Alert Level 1 Status in Sagay City, Victorias City, La Carlota City, The Municipalities Of Enrique B. Magalona, Pulupandan, San Enrique, and Candoni, and the Alert Level 2 Status of the rest of the Province Of Negros Occidental Until May 31, 2022"; and further extended under the provisions of Executive Order No. 22-25, entitled: "An Executive Order Extending the Alert Level 1 Status in Sagay City, Victorias City, La Carlota City, The Municipalities Of Enrique B. Magalona, Pulupandan, San Enrique, and Candoni, and the Alert Level 2 Status of the rest of the Province Of Negros Occidental Until June 15, 2022"; and further extended under the provisions of Executive Order 22-27, entitled: "An Executive Order Extending The Alert Level 1 Status In Sagay City, Victorias City, La Carlota City, Cadiz City, The Municipalities Of Enrique B. Magalona, Pulupandan, San Enrique, Candoni, And Pontevedra, And The Alert Level 2 Status For The Rest Of The Province Of Negros Occidental Until June 30, 2022";

WHEREAS, the IATF-EID issued Resolution 165-E, Series of 2022 downgrading the Alert Level Classification of the Cities of Sagay and La Carlota, the Municipalities of E.B. Magalona, Pulupandan and San Enrique to Alert Level 1 and thereafter, issued Resolution 166-A, Series of 2022 updating the list to include the City of Victorias under Alert Level 1 Status from April 16, 2022 until April 30, 2022; and thereafter, issued Resolution 167-A, Series of 2022 updating the list to include the Municipality of Candoni under Alert Level 1 Status from May 1, 2022 until May 15, 2022;

WHEREAS, on May 26, 2022, IATF issued Resolution 169-A, Series of 2022 stating that the Alert Level Classifications of component cities and Municipalities under IATF Resolution Nos. 165-G, 166-A, 167-A, 167-C, 167-F, and 168-G (s.2022) not otherwise affected by such Resolution shall remain in effect;

WHEREAS, on June 14, 2022, IATF Resolution 169-A placed Negros Occidental under Alert Level 2, without prejudice to its respective component cities and municipalities which may be under a different Alert Level Classification. Furthermore, the Alert Level classifications of component cities and municipalities under IATF Resolution Nos. 165-G, 166-A, 167-A, 167-C, and 167-F, and 168-G (s.2022) are not affected by this Resolution and shall remain in effect until July 15, 2022. Moreover, IATF Resolution 169-A updated the list to include the City of Talisay and Municipality of Valladolid under Alert Level 1 Status until July 15, 2022;

WHEREAS, on July 20, 2022, the Office of the Secretary of the Department of Health issued a Press Release placing the Municipality of Ilog under Alert Level 1 and Alert Level 2 for the entire Province of Negros Occidental; thus, the implementation of Executive Order No. 22-34, entitled: An Executive Order Placing The Municipality Of Ilog Under Alert Level 1, And Extending The Alert Level 1 Status In Sagay City, Victorias City, La Carlota City, Cadiz City, Talisay, The Municipalities Of Enrique B. Magalona, Pulupandan, San Enrique, Candoni, Pontevedra, Valladolid, And The Alert Level 2 Status For The Rest Of The Province Of Negros Occidental Until July 31, 2022; and was further extended pursuant to the Department of Health Press Release dated August 1, 2022;

WHEREAS, the Province of Negros Occidental has 41, 763 confirmed COVID-19 positive cases as of July 31, 2022, while the entire country has 3,776,627 confirmed COVID-19 cases as of July 31, 2022;

NOW, THEREFORE, I, EUGENIO JOSE V. LACSON, by virtue of the powers vested in me by law as Governor of the Province of Negros Occidental, do hereby order the following:

SECTION 1. EXTENDING THE ALERT LEVEL 1 STATUS IN SAGAY CITY, VICTORIAS CITY, LA CARLOTA CITY, CADIZ CITY, TALISAY CITY, THE MUNICIPALITIES OF ILOG, ENRIQUE B. MAGALONA, PULUPANDAN, SAN ENRIQUE, CANDONI, PONTEVEDRA, VALLADOLID, AND THE ALERT LEVEL 2 STATUS FOR THE REST OF THE PROVINCE OF NEGROS OCCIDENTAL FROM AUGUST 1, 2022 TO AUGUST 15, 2022. The following shall be the Alert Level Classification of the Component Cities and Municipalities of the Province of Negros Occidental until 11:59 pm of August 15, 2022:

SECTION 2. GUIDELINES FOR AREAS UNDER LEVEL 1. Areas placed under Alert Level 1 shall comply with the guidelines and protocols provided under Part I, Section 6 of the Guidelines for Nationwide Alert Level System for COVID-19 Response as of June 4, 2022 issued by the IATF-EID.

SECTION 3. TRAVEL GUIDELINES FOR ALL FORMS OF INTERZONAL AND INTRAZONAL TRAVEL IN THE PROVINCE OF NEGROS OCCIDENTAL. Pursuant to the IATF-EID Guidelines on the Implementation of Alert Levels System for COVID-19

Response, all forms of Intrazonal and Interzonal travel shall be allowed subject to the following guidelines:

A. VERIFIABLE VACCINATION CARD/ CERTIFICATE FOR INTERZONAL MOVEMENT OF FULLY VACCINATED INDIVIDUALS. Fully vaccinated individuals shall be required to present a **Verifiable Vaccination Card/Certificate** to enter the Province of Negros Occidental. Any of the following vaccination cards or certificates shall be honored by the Province of Negros Occidental:

- a. The Negros Occidental Provincial MIS Vaccination Card or
- b. A verifiable COVID-19 domestic vaccination card duly issued by a legitimate vaccinating establishment or
- c. Official Department of Health Vaccination Certificate with Quick Response ("QR") Code

B. DOCUMENT REQUIREMENTS FOR INTERZONAL MOVEMENT OF PARTIALLY VACCINATED, AND UNVACCINATED INDIVIDUALS. Partially vaccinated and unvaccinated individuals shall be required to present the following documents to enter the Province of Negros Occidental:

I. RAPID ANTIGEN TEST RESULT TO BE CONDUCTED FREE OF CHARGE BY THE PROVINCE OF NEGROS OCCIDENTAL UPON ARRIVAL. The Province of Negros Occidental shall conduct a rapid antigen test, free of charge, for arriving passengers for airports and seaports. However, the Province shall also honor the following:

a. NON-REACTIVE RAPID ANTIGEN TEST RESULT PRIOR TO TRAVEL.

- i. Shall be valid for 48 hours from date of swab sample extraction.
- ii. Must be conducted and issued by a Department of Health accredited Health Clinic or Laboratory.

C. EXCEPTION. GOVERNMENT OFFICIALS/PERSONNEL ON OFFICIAL BUSINESS. The provisions of IATF Resolution No. 98-A, Series of 2021 shall be in full force and effect. Government officials/personnel on official business shall be allowed unimpeded travel to their place of destination, provided that they:

1. Present valid IDs issued by their respective government agency;
2. Present original or certified true copy of travel authority/order issued by the Department Secretary or his/her designated official;
3. Pass symptom screening at the port upon arrival, and in case of public transport, upon boarding; and
4. Strictly comply with the minimum public health standards.

D. INDIVIDUALS WITH FAKE DOCUMENT REQUIREMENTS. Individuals/Travelers apprehended with fake documents mentioned under Section 3 of this Executive Order shall face criminal sanctions under existing laws and regulations and subject to the following:

1. A ten (10) day quarantine at a Provincial Healing Facility, and
2. An RT-PCR Test, at his/her expense, on the 5th day from arrival.

SECTION 4. AIRPORT OPERATIONS GUIDELINES. Air travel to the Province of Negros Occidental shall be subjected to the following guidelines:

- a. For Manila-Bacolod-Manila flights:
 - i. FIVE (5) flights per day for Philippine Airlines;
 - ii. SEVEN (7) flights per day for Cebu Pacific; and
 - iii. THREE (3) flights per day for Air Asia.
- b. In addition to subsection (a), Airline Companies may avail of one (1) additional inbound Manila to Bacolod cargo-only flight and one (1) additional outbound Bacolod to Manila passenger flight per day.
- c. For Cebu-Bacolod-Cebu flights:
 - i. ONE (1) flight per day for Philippine Airlines; and
 - ii. ONE (1) flight per day for Cebu Pacific.
- d. All modes of transportation shall be allowed to bring passengers to and from the airport.
- e. Minimum public health standards prescribed by the Department of Health shall be strictly enforced.

SECTION 5. SEAPORT OPERATIONS GUIDELINES. Sea travel to the Province of Negros Occidental shall be subjected to the following guidelines:

- a. Sea vessels shall be allowed to admit passengers up to 50% of its passenger capacity limit.
- b. All modes of transportation shall be allowed to bring passengers to and from the seaport.
- c. Minimum public health standards prescribed by the Department of Health shall be strictly enforced.

SECTION 6. INTER-AGENCY HEIGHTENED PATROL OF PROVINCIAL BORDERS. The Philippine National Police, the Philippine Coast Guard, the Armed Forces of the Philippines, and the Provincial Incident Management Team is hereby directed to heighten the security and patrol of the provincial borders of the Province of Negros Occidental in order to ensure compliance with this Executive Order.

SECTION 7. CLOSURE OF ESTABLISHMENTS. The following establishments shall be closed during the duration of Alert Level 2 unless authorized by the IATF-EID or Office of the President:

- a. Casinos
- b. Horse Racing
- c. Lottery
- d. Betting Shops
- e. Other Gaming Establishments

SECTION 8. LIMITED OPERATION OF ESTABLISHMENTS. Pursuant to the IATF-EID Guidelines on the Implementation of Alert Levels System for COVID-19 Response as of June 4, 2022 and DILG Memorandum Circular No. 2022-003, the following establishments shall be allowed limited operations for the duration of Alert Level 2 in the Province, subject to the guidelines provided for under Section 9 of this Executive Order:

- a. Venues for meetings, incentives, conferences, and exhibitions (MICE);
- b. Permitted venues for social events such as parties, wedding receptions, engagement parties, wedding anniversaries, debut and birthday parties, family reunions, and bridal or baby showers;
- c. Visitor or tourist attractions such as libraries, archives, museums, galleries, exhibits, parks, plazas, public gardens, scenic viewpoints or overlooks, and the like;
- d. Amusement parks or theme parks;
- e. Recreational venues such as internet cafes, billiard halls, amusement arcades, bowling alleys, skating rinks, archery halls, swimming pools, and similar venues;
- f. Cinemas and movie houses;
- g. Limited face-to-face or in-person classes for basic education subject to prior approval of the Office of the President;
- h. Limited face-to-face or in-person classes for higher education and for technical-vocational education and training;
- i. In-person religious gatherings; gatherings for necrological services, wakes, inurnment, and funerals for those who died of causes other than COVID-19 and for the cremains of the COVID-19 deceased;
- j. Licensure or entrance/qualifying examinations administered by their respective government agency, and specialty examinations authorized by the IATF subject to the health and safety guidelines as approved by the IATF;
- k. Dine-in services of food preparation establishments such as kiosks, commissaries, restaurants, and eateries, subject to DTI sector-specific protocols;
- l. Personal care establishments such as barbershops, hair spas, hair salons, and nail spas, and those offering aesthetic/cosmetic services or procedures, make-up services, salons, spas, reflexology, and other similar procedures including home service options, subject to the sector-specific protocols of the DTI; With Amendments as of October 13, 2021;
- m. Fitness studios, gyms, and venues for individual non-contact exercise and sports, subject to DTI sector-specific protocols. Provided that patrons/clients and workers/employees wear face masks at all times and that no group activities are conducted;
- n. Film, music, and television production subject to the joint guidelines as may be issued by the DTI, DOLE, and the DOH;
- o. Contact sports approved by the LGU where such games shall be held;
- p. Funfairs/*peryas* or kid amusement industries such as playgrounds, playroom, and kiddie rides;
- q. Venues with live voice or wind-instrument performers and audiences such as in karaoke bars, clubs, concert halls, and theaters; and
- r. Gatherings in residences with individuals not belonging to the same household.
- s. Cockfighting and operation of cockpits, subject to compliance with DILG Memorandum Circular No. 2022-003

SECTION 9. GUIDELINES FOR THE LIMITED OPERATION OF ESTABLISHMENTS.

Pursuant to the IATF-EID Guidelines on the Implementation of Alert Levels System for COVID-19 Response as of June 4, 2022, these are the guidelines for the aforementioned establishments allowed limited operations during Alert Level 2:

- i. **EMPLOYEES FULLY VACCINATED.** All workers/employees of the establishments listed under Section 8 of this Executive Order must be fully vaccinated against COVID-19;
- ii. **STRICT OBSERVANCE OF DOH MINIMUM PUBLIC HEALTH STANDARDS.** Department of Health Minimum Public Health Standards shall be strictly maintained at the establishment;

- iii. **OUTDOOR VENUE CAPACITY LIMIT.** All limited operation establishments shall be allowed up to 70% outdoor venue capacity to cater to individuals, regardless of vaccination status;
- iv. **INDOOR VENUE CAPACITY LIMIT TO CATER TO FULLY VACCINATED INDIVIDUALS AND MINORS.** All limited operation establishments shall be allowed up to 50% indoor venue capacity but must cater to fully vaccinated individuals only;
- v. **INDOOR VENUE CAPACITY LIMIT TO CATER TO UNVACCINATED AND PARTIALLY VACCINATED INDIVIDUALS.** All limited operation establishments which cater to unvaccinated and partially vaccinated individuals shall be allowed up to 30% indoor venue capacity;
- vi. **NO OBJECTION FROM LGU WHERE ACTIVITIES MAY TAKE PLACE.** There must be no objection from the local government unit where the activities of these limited operation establishments will take place.

SECTION 10. PROTOCOL FOR HOME QUARANTINE AND ISOLATION OF COVID-19 CASES WITH NO SYMPTOMS, MILD SYMPTOMS, OR MODERATE SYMPTOMS. The Provincial Government of Negros Occidental hereby adopts and gives full force and effect the provisions of Department of Health Memorandum No. 2022-0013, Series of 2022 as the protocol for the home quarantine and isolation of probable and confirmed COVID-19 cases with no symptoms, mild symptoms, or moderate symptoms.

SECTION 11. LIFTING OF CURFEW HOURS. The Provincial curfew hours are hereby lifted. The provisions of Executive Order No. 21-50, Series of 2021 entitled "An Executive Order Implementing the Curfew Hours to be Observed in the Province of Negros Occidental in Order to Prevent the Spread of COVID-19" is hereby revoked.

SECTION 12. INFORMATION DISSEMINATION. For effective information dissemination, all LGUs shall serve copies and apprise all barangay officials of this Executive Order.

SECTION 13. SANCTIONS FOR NON-COMPLIANCE. All persons and/or establishments who do not comply with the provisions of this Executive Order, as well as the established health and safety protocols issued by the Department of Health, the IATF-EID, other agencies, and the Province of Negros Occidental, shall face appropriate administrative and/or criminal sanctions under existing laws and regulations.

SECTION 14. REPEALING CLAUSE. All other executive issuances, rules and regulations or parts thereof which are inconsistent with this Executive Order are hereby revoked, amended or modified accordingly.

SECTION 15. AMENDMENTS. Any of the above provisions may be subject to amendments, pursuant to any issuances by the National IATF or as justified by other compelling circumstances.

SECTION 16. EFFECTIVITY. This Executive Order shall take effect immediately.
