***RESOLUTION DECLARING RESOLUTION NO. 093, SERIES OF 2021 OF THE MUNICIPALITY OF MANAPLA, NEGROS OCCIDENTAL AS A VALID ENACTMENT***

***WHEREAS***, thereby presented to the Board for review and appropriate action is Resolution No. 093, Series of 2021 of the Municipality of Manapla, approving the devolution transition plan of the Municipality of Manapla, Negros Occidental providing the Municipal government with a road map to ensure strategic, systematic and coherent actions towards the full implementation of functions, services and facilities to be fully devolved by national government agencies (NGAs) concerned starting in FY 2022;

***WHEREAS***, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it's consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

***WHEREAS***, a review of the subject resolution reveals that the same is in accord with the national policies/guidelines on the preparation of Devolution Transition Plans of Local Government Units;

***WHEREAS***, in view of the foregoing, the SP Committee on Finance recommends to declare said resolution as a valid enactment;
