WHEREAS, thereby presented to the Board for review and appropriate action is Resolution No. 21-185 of the City of Himamaylan, entitled: "Resolution approving Resolution No. 01-2021 of the Local Disaster Risk Reduction and Management Council (LDRRMC) re: Resolution approving the projects/programs/activities to be funded by the 5% Local Disaster Risk Reduction Management Fund (LDRRMC) CY 2022, in the amount of Sixty Million Fifty One Thousand Pesos (P60,051,000.00)";

**WHEREAS**, Section 106 of R.A. No. 7160, otherwise known as the Local Government Code of 1991 provides that "each LGU shall have a comprehensive multi-sectoral development plan to be initiated by its development councils and approved by its sanggunian";

WHEREAS, Section 114 of the said Code further provides that the plans, programs and projects proposed by the local development council shall be submitted to the sanggunian concerned for appropriate action;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after approval, the secretary to the sanggunian shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;
