## RESOLUTION APPROVING CITY ORDINANCE NO. 2021-015 OF THE CITY OF SIPALAY, NEGROS OCCIDENTAL

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is City Ordinance No. 2021-015 of the City of Sipalay authorizing the proposed borrowing of the City Government of Sipalay, Negros Occidental in the aggregate amount of P380,000,000.00 with the Land Bank of the Philippines to finance various priority projects;

**WHEREAS**, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the powers of the Sangguniang Panlungsod of Sipalay to enact pursuant to Sections 296(a), 297(a) and 458(a)(2)(iii) of RA 7160, otherwise known as the 1991 Local Government Code;

**WHEREAS**, the City of Sipalay has sufficiently complied with the pertinent requirements as mandated by law in the passage of the said ordinance;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
