A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2021-006 OF THE MUNICIPALITY OF ILOG “CREATING THE LOCAL COMMITTEE AGAINST PROFESSIONAL SQUATTERS AND SQUATTING SYNDICATE OF THE MUNICIPALITY OF ILOG, NEGROS OCCIDENTAL, DEFINING ITS COMPOSITION, POWERS AND FUNCTIONS AND FOR OTHER PURPOSES” AS A VALID ENACTMENT

Whereas, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it's consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Panlungsod concerned;

Whereas, Municipal Ordinance No. 2021-006 of the Municipality of Ilog, Negros Occidental, entitled: “An Ordinance Creating the Local Committee Against Professional Squatters and Squatting Syndicate of the Municipality of Ilog, Negros Occidental, Defining it's Composition, Powers and Functions, and for other Purposes” was submitted for review by the Municipality of Ilog to the Sangguniang Panlalawigan of Negros Occidental;

Whereas, after prompt examination by the Provincial Legal Office, it is the recommendation of the said office that the subject Ordinance is within the conferred power of the Sangguniang Bayan of Ilog to enact, thus, the same may be given due course by the Sangguniang Panlalawigan pursuant to Section 16 and Section 447(a) of RA 7160;

Whereas, insofar as the creation of the Local Committee is concerned, Section 18 of RA 7160 supports the Local Government Unit's authority to create an organization or body, which shall implement its program;

Whereas, RA 7279 and DILG Memorandum Circular No. 2012-04 respectively mandate the adoption of measures and the creation of committees to curtail the proliferation and activities of professional squatters;

Whereas, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

Now therefore, premises considered, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr. seconded by Hon. Jeffrey T. Tubola, Hon. Ryan Milos Romeo M. Gamboa and Hon. Victor B. Javellana;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves to declare Municipal Ordinance No. 2021-006 of the Municipality of Ilog "Creating the Local Committee Against Professional Squatters and Squatting Syndicate of the Municipality of Ilog, Negros Occidental, defining its composition, powers and functions and for other purposes", as a valid enactment.
